This general meeting of the IHBA will cover some old business topics we have been working on for recently. The State of Illinois has adopted a policy regarding the classification of non-ASME boilers new to the state (i.e., recently purchased out of state) as State Specials, with a rigorous and expensive process for certifying such boilers before they can be inspected, including engineering reports, court recorder, etc. The IHBA was well represented at the December meeting of the Boiler Rules Board to discuss this policy, and the Board is expected to make their determination at their regular meeting on March 11. We will attend, and will have a report to the IHBA on this issue at our General Meeting, and discuss our reaction as needed at that time.

Also at this meeting, we will have a presentation by Dan Kocher and Dave Stevens of the recent restoration work on the Illinois traction engine owned by the Northern Illinois Steam Power Club. This engine, originally manufactured in Sycamore, Illinois, was purchased by the Club several years ago, and underwent significant mechanical restoration last year. In addition to the normal work of pouring bearings, boring the tunnel and timing, this engine presented numerous unusual problems that had to be dealt with. The crosshead was cracked, repaired and cracked again, and a pattern was made to cast a new one using modern computer technology. A new piston was also cast, as the tunnel and cylinder were bored and uneven wear corrected. This engine has an unusual valve mechanism that we haven't completely conquered yet, and also an unusual throttle valve that was just recently worked on to try to improve its efficiency. And despite all the work done so far, there is still more work to be done.


